Worship & Ministry Highlights

- Many thanks to Church of the Trinity MCC for the gifting to MCC Kampala TLAYF with an additional Easter Offering of \$1172.00 USD. All funds were used to grow and expand the worship services. Services that benefitted were: Weekly Sunday Service, Weekly Sunday Children's Ministry, and Wednesday Evening Bible Study. How funds were spent is recorded on the quarterly financials (which are attached) but highlights included purchase of bibles, for both adult and children, and traditional drums and other musical instruments
- Chaplain Denis continues to mentor apostles and children ministry leaders to assist with worship. Year
 to date there are three (3) people he oversees. Chaplain Denis is also in conversation with a group of
 young men interested in establishing a "satellite" LGBT ministry outside of Kampala.
- Via clinic funding we were able to purchase a car for much needed safety and transportation.
- In May our MCC Kampala TLAYF Facebook page was created. We have been able to reach many both locally and internationally. We invite all board members to visit.
- Two (2) grant proposals were sent out over the last three months with hopes of receiving funds for our non-for-profit clinic HIV / AIDS outreach programs. Grants were submitted to the Steven Lewis Foundation (Canada) and UHAI-EASHRI (Kenya). We are hoping to hear back by August.
- In May the first harvest from our Community Garden took place. All greens were shared with members and local community people.
- In early June Chaplain Denis traveled to Rwanda to participate in a conference "Forward Together 2018". Conference was hosted by Rights for All Rwanda (RITA). Chaplain Denis served on the panel which addressed Spirituality, Culture, and African Identity. He also attended Rwanda Pride. Funding was provided by UCAA-UG.
- Chaplain Denis and Madam Moreen attended a four (4) day seminar sponsored by Freedom House on Project Planning and Management Training. Each completed this Certificate Educational Program.
 Most funding provided by Freedom House with additional funds acquired from clinic reserves.
- Recently Chaplain Denis received an invitation, via Rev. Wanda Floyd, to create an Emerging Church 50th video for MCC General Conference in July 2019. He has created and submitted.
- We are honored to share that Chaplain Denis was asked to submit a "Be A Gem Scholarship" application for MCC General Conference. Applications will be reviewed in July with final candidates notified by the beginning of August.
